About the Community Wi-Fi Scheme

The Community Wi-Fi Scheme has been set up to enable local communities to provide a public Wi-Fi service via their community hubs with support from the Community Initiatives Fund (CIF).

What is a 'community hub'?

A community hub is a community facility such as a village hall, community centre, parish hall, run as a charity or on a 'not for profit' basis, that is available to the public to use and hire in a particular area for community-related recreational activities. This would naturally exclude halls only available primarily for one exclusive use such as pre-schools, members clubs, etc.

The scheme is aimed at but not limited to community hubs enabled to access superfast broadband.

Community hubs can buy a broadband service from any supplier of their choice from October 2017 under this scheme. Initial set up costs will be supported by CIF and community hubs will subsequently need to pay a monthly service charge.

Community Initiatives Fund (CIF)

The Community Initiatives Fund (CIF) is a small grants scheme funded by Essex County Council, designed to fund community projects.

Money from the CIF has been set aside for the scheme to help community hubs pay for the setup costs of a Wi-Fi service as offered by the two operators under this scheme (only). Up to £400 can be claimed per community hub.
